ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Use of Net Proceeds from the Share Offer

- The Offer Price has been determined at HK\$0.375 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.375 per Offer Share and 200,000,000 Offer Shares, the net proceeds under the Share Offer are estimated to be approximately HK\$48.3 million, after deducting the underwriting commission and estimated expenses payable by the Company in relation to the Share Offer. The Company intends to apply such net proceeds from the Share Offer for the purposes as set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

The Public Offer

- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 8,449 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms, through the **HK eIPO White Form** service (www.hkeipo.hk) and by giving **electronic application instructions** to HKSCC via CCASS for a total of 608,580,000 Public Offer Shares, representing approximately 30.43 times of the total number of 20,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 15 times but less than 50 times of the number of Offer Shares initially available under the Public Offer, 40,000,000 Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 60,000,000 Offer Shares, representing 30% of the total number of Offer Shares initially available under the Share Offer.

The Placing

- The Placing Shares initially offered under the Placing have been moderately over-subscribed. The number of Placing Shares initially subscribed for is 355,460,000 Placing Shares, representing approximately 1.97 times of the total Placing Shares initially offered. As the reallocation of the Shares as described in the section headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus has been applied, the final number of the Offer Shares allocated to 221 places under the Placing is 140,000,000 Offer Shares, representing 70% of the total number of the Offer Shares under the Share Offer.

- A total of 72 placees have been allotted ten board lots of Shares or below, representing approximately 32.58% of the total number of placees under the Placing. These placees have been allotted approximately 3.73% of the 140,000,000 Offer Shares (after reallocation) available under the Placing. A total of 7 placees have been allotted five board lots of Shares, representing approximately 3.14% of the total number of placees under the Placing. These placees have been allotted 0.25% of the 140,000,000 Offer Shares (after reallocation) available under the Placing.

The Directors confirm that, to the best of their knowledge, information and belief having made reasonable enquiries, all placees under the Placing and their ultimate beneficial owners are independent of and not connected with the Company and any of the Directors, chief executive, Controlling Shareholders, Substantial Shareholders or significant Shareholders (as defined under the GEM Listing Rules) of the Company or any of its subsidiaries or their respective close associates (as defined under the GEM Listing Rules), and are not any person or group of persons as stated in Rule 10.12(4) of the GEM Listing Rules or any nominees of the foregoing, and none of the Placing Shares subscribed by the placees has been financed directly or indirectly by any of the Directors, chief executive, Controlling Shareholders, Substantial Shareholders or significant Shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees is accustomed to taking instructions from any of the Directors, chief executive, Controlling Shareholders, Substantial Shareholders or significant Shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it. None of the Sole Sponsor, the Sole Bookrunner, the Joint Lead Managers and the Underwriters or their respective close associates has taken up any Offer Shares for its own benefit under the Share Offer. No placee, individually, has been or will be placed with more than 10% of the enlarged issued share capital of the Company immediately after completion of the Share Offer and the Capitalisation Issue. The Directors also confirm that there will not be any new Substantial Shareholder of the Company within the meaning of the GEM Listing Rules immediately after completion of the Share Offer and the Capitalisation Issue.

The Directors also confirm that, immediately after completion of the Share Offer and the Capitalisation Issue, the Company will comply with (i) Rule 11.23(7) of the GEM Listing Rules that the public float of the Company will be at least 25% of the enlarged issued share capital of the Company; (ii) not more than 50% of the Shares in public hands at the time of Listing will be owned by the three largest public Shareholders as required under Rule 11.23(8) of the GEM Listing Rules; and (iii) the Shares in public hands will be held among at least 100 Shareholders at the time of Listing as required by Rule 11.23(2)(b) of the GEM Listing Rules.

Offer Size Adjustment Option

In connection with the Share Offer, the Company has granted the Offer Size Adjustment Option to the Placing Underwriters, exercisable by the Sole Bookrunner (for itself and on behalf of the Placing Underwriters) during the period from the date of the Placing Underwriting Agreement to the business day immediately before the date of the announcement of the results of allocation and the basis of allocation of the Public Offer Shares, to require the Company to allot and issue up to an aggregate of 30,000,000 additional new Shares at the final Offer Price, representing 15% of the total number of the Offer Shares initially available under the Share Offer on the same terms as those applicable to the Share Offer to cover over-allocation under the Placing (if any). The Sole Bookrunner has not exercised the Offer Size Adjustment Option by the aforesaid time and the Offer Size Adjustment Option has accordingly lapsed.

NET PROCEEDS FROM THE SHARE OFFER

Based on the Offer Price of HK\$0.375 per Offer Share, the net proceeds under the Share Offer are estimated to be approximately HK\$48.3 million, after deducting the underwriting commission and estimated expenses payable by the Company in relation to the Share Offer.

The Company intends to apply such net proceeds as follows:

- approximately HK\$24.2 million, representing approximately 50.0% of the net proceeds, will be used for the upgrading of the production line for the waxing and winding of the Group's 100% spun polyester sewing threads for industrial use;
- approximately HK\$9.2 million, representing approximately 19.0% of the net proceeds, will be used for the upgrading of the production line for the waxing and winding of the Group's 100% spun polyester sewing threads for domestic use;
- approximately HK\$4.8 million, representing approximately 10.0% of the net proceeds, will be used for the acquisition of cone winding machines for the Group's spun polyester sewing threads;
- approximately HK\$4.3 million, representing approximately 9.0% of the net proceeds, will be used for the acquisition of new machinery for the production of nylon threads;
- approximately HK\$1.5 million, representing approximately 3.0% of the net proceeds, will be used for the setting up of a sales office in Zhejiang province; and

The Directors confirm that, to the best of their knowledge, information and belief having made reasonable enquiries, all placees under the Placing and their ultimate beneficial owners are independent of and not connected with the Company and any of the Directors, chief executive, Controlling Shareholders, Substantial Shareholders or significant Shareholders (as defined under the GEM Listing Rules) of the Company or any of its subsidiaries or their respective close associates (as defined under the GEM Listing Rules), and are not any person or group of persons as stated in Rule 10.12(4) of the GEM Listing Rules or any nominees of the foregoing, and none of the Placing Shares subscribed by the placees have been financed directly or indirectly by any of the Directors, chief executive, Controlling Shareholders, Substantial Shareholders or significant Shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees is accustomed to taking instructions from any of the Directors, chief executive, Controlling Shareholders, Substantial Shareholders or significant Shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it. None of the Sole Sponsor, the Sole Bookrunner, the Joint Lead Managers and the

Underwriters or their respective close associates has taken up any Offer Shares for its own benefit under the Share Offer. No placee, individually, has been or will be placed with more than 10% of the enlarged issued share capital of the Company immediately after completion of the Share Offer and the Capitalisation Issue.
